#### HOUSE CONCURRENT RESOLUTION NO. 57

DESIGNATING FEBRUARY 14, 2018, AS "SOCKS FOR THE HOMELESS DAY" IN THE STATE OF DELAWARE.

Ì	WHEREAS, according to the National Alliance to End Homelessness, on a single night in January 2015, there
2	were 564,708 people experiencing homelessness across the United States; and
3	WHEREAS, according to the Delaware State Housing Authority, 8,353 people are homeless every year in
4	Delaware; and
5	WHEREAS, a pair of socks is a basic human need and a lack of socks can lead to frostbite, blisters, and ulcer
6	formations and inevitable loss of limb and amputation; and
7	WHEREAS, clothing donations to the homeless rarely include socks; and
8	WHEREAS, the need for clean, dry socks is imperative to decrease the likelihood of fungal and bacterial infection
9	that can be harbored in a shoe liner and which lead to infection, causing cellulitis and skin infection; and
0	WHEREAS, socks protect the feet from the internal structures of shoes as well as helping insulate the feet from
1	cold surfaces, especially for those who deal with rheumatoid arthritis; and
2	WHEREAS, socks are a simple item that can make a large difference for an individual who is homeless; and
3	WHEREAS, new socks can protect children from splinters and provide a barrier against fungal nail infections
4	caused by not wearing socks with borrowed or donated, previously worn shoes; and
5	WHEREAS, owning new, non-tattered socks can provide dignity to people who otherwise only have 1 pair of
6	socks; and
7	WHEREAS, the Charity Crossing and The Joy of Sox were created to accept and manage donations from all over
8	the United States; and
9	WHEREAS, the Charity Crossing and The Joy of Sox continue to raise awareness of the plight of individuals who
20	are homeless and the medical problems associated with being homeless and without socks.
21	NOW, THEREFORE:
22	BE IT RESOLVED by the House of Representatives of the 149th General Assembly of the State of Delaware, the
23	Senate concurring therein, that February 14, 2018, is recognized as "Socks for the Homeless Day" in the State of Delaware Page 1 of 2
